- c. इस विवरण पुस्तिका में दी गयी सूचनाओं के अतिरिक्त यदि किसी विशेष संस्थान के विषय में अधिक जानकारी की आवश्यकता हो तो उस संस्थान के अधिकारी से सीधे पत्राचार करें।
- d. इस विवरण पुस्तिका में दी गयी सूचनाओं में यदि कोई संशोधन/ परिवर्त्तन होगा या कोई अतिरिक्त सूचना होगी तो उसे आवेदकों को उनके साक्षात्कार के समय या इसके पूर्व ही यथासाध्य सूचित कर दिया जायेगा।
- e. समय-समय पर Website के माध्यम से UGMAC-2024 की कॉउन्सेलिंग से संबंधित आवश्यक सूचना / सूचनायें दी जाती रहेंगी। उत्सुकतावश बार-बार अनावश्यक पत्र कृपया न लिखें, क्योंकि ऐसे पत्रों का उत्तर देना संभव नहीं होगा।
- f. UGMAC-2024 हेतु निर्गत इस विवरण पुस्तिका/ आवेदन प्रपत्र आदि में सिम्मिलित किसी नियम/ सूचना को परिवर्तित/ विलोपित करने अथवा जोडने का अधिकार बिहार संयुक्त प्रवेश प्रतियोगिता परीक्षा पर्षद के पास सुरक्षित है।
- g. इस परीक्षा के लिये यदि किसी अभ्यर्थी की उम्मीदवारी रद्द की जाती है तो इसके लिए उसे सुचित करने की बाध्यता नहीं होगी ।
- h. (क) अगर कोई अभ्यर्थी UGMAC-2024 के पूर्व, परीक्षा में या परीक्षा के उपरान्त, मेधा-सूची प्रकाशन के बाद या / एवं नामांकन होने के पश्चात् कभी भी गलत/ त्रुटिपूर्ण या नकली प्रमाण पत्र प्रस्तुत करने का दोषी पाया जाता है तो नामांकन हेतु उसकी उम्मीदवारी स्वत: रह हो जायेगी।
  - (ख) यदि कोई परीक्षार्थी कदाचार में लिप्त होने अथवा Impersonation का दोषी पाया जाता है या NEET(UG)-2024 की परीक्षा कक्ष में मोबाइल / इलेक्ट्रानिक गैजेट / ब्लूटूथ का उपयोग करते अथवा उसके / उनके साथ पकड़े जाने की पुष्टि होती है तो नामांकन हेतु निर्गत आवंटनादेश स्वत: रह हो जायेगा ।
- i. NEET (UG)-2024 की मेधा-सूची में सम्मिलित सभी अभ्यर्थियों को अपने खर्चे से स्वयं कॉउन्सेलिंग / इन्टरभ्यू में, प्रमाण पत्रों एवं पहचान की जाँच आदि के लिये निश्चित तिथि एवं समय पर उपस्थित होना आवश्यक होगा अन्यथा नामांकन हेतु वे अपना दावा खो देंगे।
- j. कॉउन्सेलिंग / इन्टरभ्यू में मूल प्रमाण पत्रों / अभिलेखों की जाँच आदि के लिये अभ्यर्थी के स्वयं केवल उपस्थित हो जाने पर ही नामांकन हेतु उसका कोई दावा नहीं बनेगा ।
- k. अगर भूलवश किसी अभ्यर्थी को UGMAC-2024 की कॉउन्सेलिंग में सिम्मिलित होने की अनुमित मिल जाती है जो अन्यथा नहीं मिलनी चाहिए थी और नामांकन के पूर्व या उसके पश्चात् कभी भी इस भूल का पता चलता है तो वह मेधा-सूची में सिम्मिलित होने के बावजूद नामांकन हेतु अपना दावा / अधिकार खो देगा । अगर इस सम्बन्ध में कोई वैधानिक विवाद उत्पन्न होता है तो ऐसी परिस्थिति में इस मामले में अन्तिम निर्णय होने तक अभ्यर्थी को नामांकन-आदेश निर्गत नहीं किया जायेगा।
- 1. नामांकन प्रक्रिया समाप्ति की घोषित तिथि के बाद किसी भी संबंधित संस्थान/ पाठ्यक्रम में किसी प्रकार की रिक्तियाँ फिर नहीं भरी जायेंगी।
- m. UGMAC-2024 के संचालन तथा इससे सम्बन्धित आवेदन प्रपत्रों से संबंधित सभी विवाद केवल पटना नगर स्थित न्यायालयों के क्षेत्राधिकार के अंदर ही दायर किये जायेंगे और वही मान्य होंगे । बिहार संयुक्त प्रवेश प्रतियोगिता परीक्षा पर्षद के लिए परीक्षा नियंत्रक ही वैधिक व्यक्ति होंगे जिनके माध्यम से पर्षद वाद दायर कर सकेगी अथवा पर्षद के विरुद्ध वाद दायर किये जा सकेंगे ।

## 12. **Conditions for MBBS / BDS Counselling :** METHOD OF SELECTION AND ADMISSION given below will be subject to updated Rules of NMC / MCC;

## 12.1 Merit List:

- a) Merit list of all the qualified candidate as provided by the Deptt. of Health, Govt. of Bihar based on NEET (UG)-2024 will be the basis for UGMAC-2024.
- b) There will be four (4) round of Counselling i.e. Round-1, Round-2, Round-3 and Stray Vacancy Round.
- c) All round Counselling i.e. Round-1, Round-2, Round-3 and Stray Vacancy round will be Online.
- d) For Round-3, Fresh Online Registration and Submission of Application Form For 3rd Round Online Counselling, Fresh online Registration & submission of Application Form, from those candidate who has not Registered and submitted Application Form of UGMAC-2024 earlier i.e. before 1st round Counselling, will be taken. Details will be made available through concerned advertisement.
- 12.2 (a) (i) On the basis of merit list of UGMAC-2024 of eligible candidate, the candidate has to fill his choices online for UGMAC-2024 counselling. Please note that choice filling facility will be available as per schedule published in concerned Advertisement. After completion of choice filling process, seat allotment result will be published on Board's website. In case candidate is allotted seat during 1st round seat allotment then he has to report physically at reporting centre for document verification. After document verification, if he is found eligible he will either take admission or go for free exit. But if he has given willingness for up-gradation during downloading of 1st round provisional seat allotment order then after document verification, he will wait for 2nd round seat allotment and his submitted document will be retained at

- reporting centre. But if his choice is upgraded in Round-2, then the candidate will have to join the college on allotted seat during second round.
- (ii) After publication of 1st round seat allotment result, the candidates who are allotted a seat shall download their provisional allotment order by login on counselling portal but before downloading of provisional allotment order, it is necessary for the candidates to give option for upgradation as 'Yes' or 'No'.
- (iii) The candidate who gets allotted a seat during Round-1 counselling and given their upgradation for Round-2 counselling as 'No', then candidate will have to report physically to their reporting centre within scheduled period as printed on the provisional allotment order of Round-1 counselling with all required original documents for Identity and document verification. After document verification, if the candidate is found eligible he will take admission with payment of requisite Fee and their all original documents will be retained at the reporting centre and candidate will be provided a Document Verification Slip of Round-1 counselling.
- (iv) In case the seat allotted in Round-1 Counselling is retained in Round-2 Counselling then the candidate will have to report physically to their reporting centre within scheduled period as printed on the provisioanl allotment order of Round-2 Counselling with their Round-1 document verification slip and will have to take admission with payment of requisite Fee.
- (v) In case of upgraded seat allotment in Round-2, the candidate will have to collect their all submitted original documents from Round-1 reporting centre and then will have to report physically to their reporting centre within scheduled period as printed on the provisional allotment order of Round-2 Counselling with all required documents in original and Round-1 document verification slip for Identity and Document Verification. After document verification, if the candidate is found eligible then their all original documents will be retained at the reporting centre and will have to take admission with payment of requisite Fee.
- (vi) If the candidate's seat of Round-1 is retained in Round-2 then the candidate has to take admission.
- (b) The candidate who got allotted a seat during Round-1 counselling and given their upgradation for Round-2 counselling "Yes" or "No" but due to any reason did not reported physically to their Reporting Centre within scheduled period as printed on the Provisional Allotment order of Round-1 counselling with all required documents in original for identity and Document Verification, then in such case their Round-1 allotted seat will be cancelled and will not be considered for upgradation in Round-2 counselling (if given their upgradation for Round-2 counselling as "Yes") but will be eligible for Fresh Choice Filling of Round-2 Counselling. Such candidates will also be treated as Free Exit from Round-1 Counselling.
- (c) After joining the allotted seat in Round-2, the candidate will not be eligible to participate in any further round of counselling.
- (d) Candidate who did not get any upgradation in Round-2 will continue to study in the same college and seat and he cannot resign the said seat in Round-2.
- (e) Allotment will be made through online mode for the all round counselling i.e. Round-1, Round-2, Round-3 and Stray Vacancy round.
- (f) Fresh choice filling / Modification can be done for Round-2 Counselling by all eligible following candidates:
  - (i) Who are included in the merit list of UGMAC-2024 and are eligible but did not completed the choice filling process on counselling portal for Round-1 Counselling.
  - (ii) Who have been allotted a seat in Round-1 Counselling and taken free exit within prescribed date.
  - (iii) Who have been allotted a seat in Round-1 Counselling either with upgradation 'Yes' or 'No' but not reported to reporting centre.
  - (iv) Who have been allotted a seat in Round-1 Counselling and given their upgradation as 'Yes' as well as completed the process of document verification at reporting centre during Round-

- 1 Counselling, candidate will have the facility to Swap / Add / Up / Down their Choices but he will not have the facility to Remove / Deleted their Round-1 allotted choice from the choice list.
- (v) Whose Round-1 Counselling allotted seat cancelled due to discrepancy generation during document verification.
- (vi) Who have not been allotted any seat in Round-1 Counselling.
- (g) On the basis of online choice filling of the candidate, provisional seat allotment order will be issued. Final seat allotment/admission will be subject to verification of their identity and original certificates at reporting centre fixed by the Board.
- (h) Before downloading of provisional seat allotment order, it is necessary for those candidate who want to upgrade their allotted seat, to give willingness for upgradation as "Yes" else "No".
- (i) If a candidate has opted for Upgradation in Round-1 but if his seat of Round-1 is retained in Round-2, then he cannot quit this seat.
- (j) Candidates allotted to an institution in Round-1 / Round-2 will be treated as admitted, (except those candidates who have availed the option of free exit in writing after Round-1)
- (k) A candidate who has filled his choices online for UGMAC-2024 counselling within the prescribed period and could not get any seat either in Round-1 / Round-2 of the UGMAC-2024 counselling or has taken admission either through Round-1 / Round-2 Counselling, then his security deposit amount will be credited in his Bank account from which he has deposited the same after end of all round of counselling. Only such candidates are eligible for Round-3 Counselling, who are not admitted in any Medical/ Dental College of India through NEET (UG)-2024.
- (l) Candidate's security amount will be forfeited;
  - (i) If candidate does not take admission on retained seat of Round-1, upgraded seat of Round-2 or fresh allotted seat of Round-2.
  - (ii) If candidate found not eligible during Round-2 Counselling document verification.
- (m) During document verification of any Round of counselling, if any kind of discrepancy is being generated by the reporting centre, then their allotted seat of concerned round counselling will be cancelled for which candidate will be solely responsible. Candidates are required to collect the Discrepancy Slip from the reporting centre after Document Verification.
- (n) The candidate whose allotted seat will be cancelled due to generation of discrepancy during document verification of Round-1 counselling will be also eligible for Fresh Choice Filling of Round-2 Counselling on the basis of updated data.
  - [Example: If a candidate has filled up their category as BC and gets allotted their seat on BC seat but during document verification, it is found that candidate does not belong to BC category then in such case their category will be updated to Unreserved (UR) category for Round-2 counselling. Their Round-1 counselling allotted seat on BC Category will get Cancelled.]
- (o) Once a candidate joins his 2nd round seat he will not be allowed to vacate from allotted 2nd round seat as per direction by Hon'ble Supreme Court in WP(C) (267/2017) dated 09.05.2017.
- (p) Candidates are advised to visit official BCECE Board https://bceceboard.bihar.gov.in/ website regularly for latest updates.
- (q) In case of any discrepancy / confusion in counselling the guidelines issued by NMC, New Delhi will be followed.
- 12.3 a. Institution / course / subject / category wise seat matrix is available on परिशिष्ट-1, परिशिष्ट-2 & परिशिष्ट-3.
  - b. For admission in reserve categories, all Institutions will be considered as one unit.
  - c. Dates and venue of documents verification by personal appearance will be available on provisional allotment letter, candidate should bring all relevant original documents as mentioned in prospectus of UGMAC-2024 at the time of document verification, along with a set of photo state copy of each certificate / document.

- d. A candidate in Round-2 Counselling, if found eligible in all respect after due verification of his documents and identity, will have to join the course within prescribed period of time failing which the candidature of the candidate will be rejected and deposited security deposit will be forfeited.
- e. The candidates belonging to Unreserved / EWS Category have to secure at least 50 percentile marks/ Unreserved & EWS DQ candidates have to secure at least 45 percentile / candidates belonging to SC, ST, EBC & BC reserve Categories have to secure at least 40 percentile marks / SC, ST, EBC & BC DQ candidates have to secure at least 40 percentile in the competitive test of NEET (UG)-2024, in order to fulfil the minimum performance criterion as fixed by the National Medical/Dental Council to be eligible for admission in MBBS/BDS course.
- f. No candidate will be permitted to pursue and complete more than one course from the same Examination [NEET (UG)-2024] and the same session.
- g. No candidate will be enrolled for two courses simultaneously.
- h. Updated Rules of NMC / MCC will be followed.
