NOTE: Candidates who have already registered for UGCET-2024 **NEED NOT** submit the fresh application once again for UGNEET-2024.

NOTIFICATION-1- For the candidates who have already registered for UGCET-2024

Candidates who have already registered for UGCET-2024 and who have scored more than or equal to the prescribed minimum score in UGNEET-2024 have to enter their correct UGNEET-2024 Roll Number from 11.00 am on 05-08-2024 to 07-08-2024 – 11.00 am, in the online registration link "UGNEET-2024 only Roll Number Entry" in KEA Web-portal. UGNEET Roll Number should be entered by using their USER ID and Password already created for UGCET-2024 to become eligible for admission to Medical, Dental and AYUSH courses. UGNEET Roll number entered by the candidate will be tallied with the NTA data and qualified in UGNEET-2024 will be permitted to take the print out of UGNEET 2024 application.

Please note that SC/ST/OBC eligibility criteria are applicable to Karnataka SC/ST/OBC candidates only.

Information about downloading of Verification Slip and documents verification

- 1. Candidates should verify the UGNEET Roll Number printed in the UGNEET-2024 Application Form and then download the UGNEET verification slip from KEA Website. As the verification is completed through online, verification of documents is not required once again. Candidates have to enter the options as per the schedule.
- 2. There will not be any further verification to the Linguistic Minority and Religious Minority candidates if it is printed 'YES' against the Minority Linguistic or Minority Religious reservation in the UGNEET verification slip. They have to enter the options as per the schedule. (There will be no provision to claim reservation in the application at this stage)
- 3. In case, if it is printed as Minority Linguistic "NO" or "-" or "Blank" in the UGNEET-2024 Verification Slip even though the candidate has claimed Minority Linguistic as Telugu, Tulu, Tamil, Kodava and also mentioned 10 years study details between 1st to 12th standard in the UGCET-2024 application, then they have to come for verification in person to KEA, Bangalore in person either on 05-08-2024 or on 06-08-2024 (10.00 am to 4.00 pm) with all the relevant original documents. (There will be no provision to claim reservation in the application at this stage)
- 4. In the UGCET-2024 application, candidates who have claimed Category-2 to Category-8 in St. John Medical College, Bangalore, should appear for verification of documents in person as per the <u>below schedule</u> with all the relevant original documents at KEA, Bangalore. (Category-1 and Category-9 of St. John Medical College, Bangalore <u>need not</u> appear for verification) Further, candidates who have claimed "Clause-Z" or NRI Ward should also appear for verification as per the <u>below schedule</u>.
